- N4660 Timbercrest Drive E – Fiber Optic box on property – dirt has settled leaving a hole that needs filling. That is a utility issue and not a town issue.
- N5685 Stone Hill Rd – Snowplow took a chip out of the driveway. Wants it to be repaired. Driveway is higher than the road. Town will not repair this.
