- **Town of Medary Newsletter**
- Season's Greetings Everyone!
- We hope everyone has enjoyed the pleasant weather we've been experiencing. As the season changes, it won't be long before winter arrives.
- **Recent Town Board Updates**
- Since our last newsletter, the Town Board has been actively working on several projects:
 - - Replacement of large culverts in the Meadow Wood neighborhood
 - - Chip sealing of several roads in the Meadow Wood neighborhood
 - - Modification of our fire protection contract with the City of La Crosse, allowing funds to be directed toward training, equipment, and other resources that benefit the Town
 - - Transition to General Engineering Company for building permits and inspections
 - - Reminder: Residents must continue to contact La Crosse County Zoning first for construction projects
 - - Ongoing meetings of the Town Plan Commission to explore and implement initiatives outlined in our comprehensive plan
 - - Successful completion of the annual Funday event; a new piece of playground equipment has been ordered and is scheduled for installation in the spring
- **Financial Update**
- - The Town Board made the difficult decision to raise the Town's portion of property taxes by 10%.
- - This increase was approved by the Town electors and was necessary to account for State required property assessment updates.
- - The adjustment will help ensure the Town can continue funding essential services, maintain infrastructure, and support community priorities.
- - We thank all residents for their understanding and continued support. Your cooperation allows the Town to meet its obligations while investing in the future of our community.
- **Preparing for Winter**
- As winter approaches, we extend our sincere appreciation to the dedicated Town of Medary Road
- Crew. Their commitment ensures our roads remain safe throughout the season. Please keep the following reminders in mind:
 - - Snow Plowing: Roads are plowed once snowfall has ended, or as necessary during a heavy snowfall. If a road is missed, **notify the Town Hall directly. Do not** contact the snow removal contractor.
 - Sand/Salt Mixture: Available behind the Town Hall in the sand shed for residents to use on driveways

Refuse/Recycling

The 2026 Recycler brochure will be mailed out in mid-December. The first and last page has general information on recycling. Pages 2 and 3 have information that pertains only to the Town of Medary. Please save this brochure for future reference. If you do not receive it or need additional brochures, they are available at the Town Hall. Your 2026 Recycler has the Refuse/Recycling Collection Calendar, map and information on how to correctly prepare your Refuse/Recycling materials.

Christmas Tree Collection

A dumpster will be available from December 26, 2025 until January 12, 2026 behind the Town Hall for tree disposal. Please remove all tinsel as well as the plastic tree bag before placing them in the collection box. Please do not throw them on the ground.

Burning Permits

Burning permits are for 5 DAYS ONLY!

Remember you must get your permit before you burn, from the Town Hall during business hours, a board member or from one of the following:

Still looking for someone to be a fire warden in the Wolf Ridge/ County Road B area.

- We encourage you to burn your brush/yard waste during the winter months when there is a snow cover.
- The La Crosse Fire Department advises against creating a huge fire, but a smaller one that can be fed from a larger pile.
- **Also, remember to call the non-emergency numbers on the upper right corner of the permit before and after you burn each day. Make sure your fires are out before you call when finished burning!**

Building Permits

The Town of Medary is now contracting General Engineering Company for our building permits and inspections. If you are planning to build or remodel in the future, your first step is to contact La Crosse County Zoning. After you have a zoning permit, you will need to contact GEC to get your building permit. You can apply for your building permit on line at www.generalengineering.net or call the office at 608 742 2169.

-Landscaping Restrictions: Do not place landscaping within 33 feet of the road centerline, as this is the Town's right-of-way.

-Garbage /Recycling bins: Remove bins from the roadside within 24 hours of collection

- Mailbox Clearance: Keep the area around your mailbox free of snow and ice. If a mailbox is damaged, notify the Town Hall so the Road Crew Supervisor can inspect.

- Road Shoulder Maintenance: Snowplows may damage shoulders and grass. Please note that the Town will not repair grass in the spring, as this area is part of the right-of-way.

- Safe Driving: Reduce speed on snow-covered roads. While the Road Crew will remove snow and slush, cautious driving is essential for safety.

Important Reminder: Internet Scams

With internet scams on the rise, please be aware:

- The Town will never call, text, or email residents to demand payment.

- Tax bills will be sent through the U.S. Postal Service.

- If you receive suspicious communication, please contact the Town Hall and/or the Sheriff's Office.

Tax Information

Please note: the special charge on your tax bill is for Fire Protection

- All payments (first half or full) are due by January 31, 2026.
- Make checks payable to:
Town of Medary.
- Please include the payment stub from your tax bill and a self-addressed stamped envelope if you want a receipt mailed to you.
- Dog licenses may be paid at the same time with a separate check. Please see below.
- Taxes may be paid as follows:
- 24/7 using the drop box at the Town hall
- By mail to: Treasurer, N3393 Smith Valley Road, La Crosse, WI 54601
- In person at Town Hall during the hours below:

- To verify that your payment has been processed, go to: lacrossecounty.org
- Click on: How Do I
- From the drop down menu under “Find”
- Click on tax/parcel search
- Accept and sign in as guest
- Enter your information & perform search
- Click on your record
- Click on “taxes” on the top of the screen.
- Allow one week for processing.

Dog Licenses

All dogs over 5 months old must be licensed by April 1, 2026 (limit 2 dogs per household). We have a computer printout of dogs previously licensed in the Town of Medary. If the rabies vaccination is current, just send the correct fee along with a self-addressed stamped envelope for return of tags. If the rabies shot has expired since you purchased last year's tag, you will need to provide proof of the current rabies vaccination. It is the dog owner's responsibility to provide the rabies information (not the vet clinic). For new dogs, please provide date of birth, dog's name, breed, color, sex (provide documentation, if altered).

Dog Fee:

\$12 if spayed or neutered

\$23 if not

Dog licenses can be purchased from the town treasurer N3393 Smith Valley Road, La Crosse, WI. This can be done by mail, town hall drop box, in person during tax collection or regular town hall hours. Late payments (after April 1) are paid to the La Crosse County Clerk and subject to a fine. All dog calls are handled by the Coulee Region Humane Society at 608 -781-4014.

For new residents or for newly acquired dogs, all tags are to be purchased from the local treasurer within 30 days or a late fee may apply. A new puppy must be licensed within 5 months of birth or a late penalty may apply.
